



Idis Hospital Pharmacist of the Year Award 2017

The Hospital Pharmacist of the Award recognises a hospital pharmacist who demonstrates leadership and exemplifies the evolution of the pharmacy profession toward an expanded role in health care. The winner will demonstrate significant contributions to the pharmacy industry overall resulting in meaningful improvements in the quality of patient care and improved delivery models and pharmacy's role on the health care team.

JUDGES WILL BE LOOKING FOR:

- Evidence of long-term, consistent dedication and outstanding achievements that have led to the advancement of the profession of pharmacy and public health
 - Evidence of a large variety of skills, attributes and accomplishments
- Evidence of an individual strong in character, cumulative professional accomplishments and the ability to properly represent and model what pharmacy as a profession encompasses
- Evidence of an understanding the goals of pharmacy, and significantly contributing to how these goals may be achieved

WHO CAN ENTER?

This category is open to all hospital pharmacists working within the hospital sector in Ireland. Applications can be through nominating an individual or yourself. Previous Hospital Pharmacy Awards Hospital Pharmacist of the Year entrants, including winners, are also welcome to submit entries this year.

All entries will be judged by an independent panel of experts and the winners will be announced at the Hospital Pharmacy Awards 2017 on Saturday, September 16th in the Clayton Hotel, Dublin.

HOW TO ENTER:

For each award category you wish to enter you must fill in your full contact details in the spaces provided and ensure you answer all the questions. Your application must not exceed 800 words in answering questions one to four.

Please note your supporting material does not count towards your 800 word limit. Send a maximum of 4 high resolution images to accompany your application (of the nominee and/or the pharmacy/team along with any additional material to support your application.
